**DIRECTIONS TO THE MASONIC VILLAGE AT BURLINGTON  
FELLOWSHIP CENTER  
1114 Oxmead Road  
Burlington, N.J. 08016**

**From Interstate 295**

Take Route I-295 to Exit 47 (Burlington-Mount Holly) and head towards Burlington, which places you on County Route 541 North. Before light, bear right onto Route 541 Bypass and follow to next traffic light. Turn right at light onto Fountain Avenue and follow approximately 1.5 miles to next traffic light. At light, turn right onto Jacksonville Road and continue just past Masonic Village on right, then right onto Oxmead Road. Follow Oxmead Road, 4/10 mile. Entrance to Fellowship Center is on your right.

**From New Jersey Turnpike (Exit 5)**

At traffic light, turn left onto County Route 541 North and continue for 8/10 mile. Right after passing Avalon Carpet & Tile, turn right onto Bromley Blvd. Follow Bromley Blvd. 1.5 miles to 2nd traffic light, and turn left onto Hancock Drive. Follow Hancock Drive (which turns into Oxmead Road) 2.9 miles. Entrance to Fellowship Center is on your left.

**From Route 130**

Take Route 130 to Burlington and turn onto Jacksonville Road heading south. Continue on Jacksonville Road for 1.6 miles (3-traffic lights), and after passing Masonic Village on your right, turn right onto Oxmead Road. Follow Oxmead Road, 4/10 mile to entrance to Fellowship Center on right.

**From Route 38 (Pemberton Area)**

Take Route 38 through Mount Holly and turn right onto Route 541 Bypass (across from Lowes). Follow Bypass to end (3rd traffic light) and turn left onto County Route 541 North. Continue 2.5 miles (pass Home Depot, Kohls shopping center) and just past Avalon Carpet & Tile, turn right at traffic light onto Bromley Blvd. Follow Bromley Blvd. 1.5 miles to 2nd traffic light, and turn left onto Hancock Drive. Follow Hancock Drive (which turns into Oxmead Road) 2.9 miles. Entrance to Fellowship Center is on your left.
