New Rates for Wood Waste – January 2010

*The Burlington County Resource Recovery Complex employs
state certified truck scales to provide accurate weights of all loads of wood.*

*Chipped Tree Wood (- 2 inches)	FREE	—	FREE

Painted wood wastes are prohibited except in the mixed wood category. Treated wood wastes are prohibited except in the treated wood category. If any treated wood is present in any other category, the treated wood rate will apply to the weight of the treated wood plus a handling fee of \$160.00. 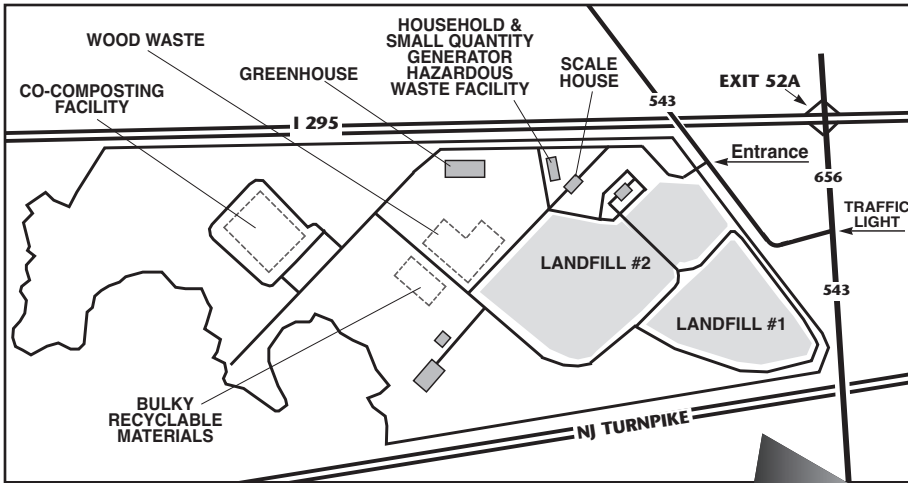
The Complex is located at the Columbus Exit 52A off Interstate 295.

MANDATORY Access & Egress Route *for use of* Burlington County Resource Recovery Complex



MANDATORY ACCESS ROUTE

All truck traffic entering the Complex shall utilize Interstate 295 to the Columbus exit 52A. Exit to County Route 656, also known as Florence Rd., for three-tenths of a mile. Turn right at the light onto County Route 543 and travel west for four-tenths of a mile to the entrance of the Complex. The entrance to the Complex will be to the left next to the blue water tower. Within the Complex, all truck traffic shall enter the main entrance road to the scale house.

MANDATORY EGRESS ROUTE

All traffic exiting the complex shall follow the reverse of the above cited access route to reach Interstate 295, then travel to another exit and a secondary route.

EXCEPTIONS

The mandatory access and egress route shall not apply to the following vehicles:

1. Pick-up trucks driven by employees to and from the Complex;
2. Vehicles hauling materials generated within the Townships of Florence, Mansfield or Springfield;
3. Vehicles traveling from the Complex to a destination within the Townships of Florence, Mansfield or Springfield.

ENFORCEMENT

In addition to any other remedy authorized by law, any person found violating the access or egress route requirement may be banned or otherwise restricted from using the Complex.
