## TWO NEW EXHIBITS ON DISPLAY AT HISTORIC SMITHVILLE PARK

Hand-hooked Rugs in the Worker's House and Gallery through Oct. 28

36th Annual Juried Art Show in the Smithville Annex Gallery through Nov. 1

The Historic Smithville Park will host original artwork by artists from the tri-state area and more than 70 colorful hand-hooked rugs this month. Both exhibits are sponsored by the Burlington County Board of Chosen Freeholders and admission is free.

"Residents from around the area can visit the beautiful Smithville Mansion and enjoy a wealth of art and exhibits from local artists," said Burlington County Freeholder Mary Ann O'Brien. "Burlington County has so many talented people and it is wonderful to see their hard work displayed."

Hosted by the Pinelands Rug Hookers in the newly-restored 1865 Worker's House and Gallery at Smithville, "2012 Hooked Rug Exhibit" will remain on display through Oct. 28. A reception to meet the rug hookers will be held on Sunday, Oct. 7 from 1:30 pm to 3 pm.

The Hooked Rug exhibit showcases the work of talented fiber artists, including rugs, wall art, table runners, stools and other goods. A variety of styles are on display, such as geometrics, abstracts, primitive, traditional and modern. Visitors will find members of the Rug Hookers organization demonstrating this unique traditional craft during exhibit hours. Gallery hours are Wednesdays from noon to 3 pm, and Saturdays and Sundays from 11 am to 3 pm (closed on legal holidays.

The 36<sup>th</sup> Annual Juried Art Exhibit showcasing the work of artists from throughout the tri-state area will remain on display in the Smithville Mansion Annex Art Gallery through Nov. 1.

A nationally-known portrait artist, John Ennis will conduct a monochromatic portrait workshop for artists and aspiring artists on Saturday, Oct. 6 from 9 am to 4 pm at the Smithville Annex Art Gallery. The cost is \$20 per person and all materials are included.
