**BURLCO SCHEDULES 11 FLU SHOT CLINICS SATURDAY TO MARCH 4**

**New Locations Offered Throughout the County**

The Burlington County Health Department has scheduled about a dozen H1N1 vaccination clinics for county residents from Saturday, Feb. 20 through the first week of March in various locations throughout the county.

This will be the last time both the Burlington Center and Moorestown Mall will offer vaccinations.

"We encourage all county residents to take advantage of one of our several clinic date offerings. We have extended our clinics into March and at various locations in hopes that this will make the vaccine more easily accessible for the community," said Health Officer Robert Gogats.

A limited supply of seasonal flu vaccine will also be available.

Residents are asked to visit the Burlington County website at [www.co.burlington.nj.us](http://www.co.burlington.nj.us) and complete the H1N1 consent form online and print a copy to bring to the clinics. If a computer is not available, consent forms can be completed at the clinics.

The Health Department continues to encourage residents to follow steps to help prevent the spread of flu at home, in the workplace, schools and throughout the community. In addition to receiving the vaccine, people should wash their hands frequently, cover coughs and sneezes, and stay home from school or work if sick.
