Petitions may not be circulated without the candidate(s)'s name, address, and office sought written on the petition.

- Print the petition on one-sided pages.
- Carefully review the petition and fill in all the blank spaces.
- Please write clearly. Do not type, pre-fill, or e-sign signatures.
- Candidates must be registered voters, be at least 18 years old, and have resided in Burlington County for at least one year prior to the General Election (Chapter 94 Laws of 1980).
- Candidates filing jointly can associate under the same slogan or designation and waive their right to be drawn individually.
- Candidates seeking different offices or terms of office must submit separate petitions.
- Every candidate must sign a Certificate of Acceptance and Oath of Allegiance, which must be notarized.
- P.L. 2018, Chapter 66 requires each candidate to provide a personal or campaign email address. Candidates should not use official government email addresses.
- The person whose presence the petition was signed in (the circulator) MUST be one of the petition signers and must make an affidavit as an Affiant before a notary or other officer authorized by law to take the affidavit.
- Per P.L. 2014, Chapter 83, the person who circulates the petition shall be a registered voter in this State whose party affiliation is of the same political party named in the petition.
- Petitioners must sign their names in their own handwriting, ensure their signatures match those on their voter registration, and provide their correct address in front of the person witnessing the signatures.
- Candidates may circulate and sign their petitions. Candidate signatures count toward the total required.
- The circulator (the person collecting signatures) MUST sign the petition and specify where they signed.
- Only legally qualified voters in New Jersey who reside in the same municipality or, for ward candidates, in the same ward, are allowed to sign the petition.
- Each voter is allowed to sign for the same candidate only once and must not sign for more candidates than the available seats.
- The Burlington County Clerk's Office will hold a public ballot draw at 3 PM on the 61st day before the Primary Election, at the County Clerk's Office located at 50 Rancocas Road, 3rd Floor, in Mount Holly.
- The primary ballot will be arranged by office position instead of by column or row, with each office on the ballot ordered randomly based on the ballot draw.

Recommendations for Petitioners

- Begin the process and submit your petition early.
- Obtain 10% to 20% more signatures than the minimum required.
- Make sure everything is signed and notarized correctly, and that all requested information is included. If you want a nickname or alternate name to appear on the ballot instead of your legal name, include a letter requesting this with your petition.
