RULES AND REGULATIONS FOR INMATES SENTENCED TO WEEKEND PROGRAM

The following rules and regulations apply to you as an inmate sentenced by the courts to serve a weekend sentence and to participate in the weekend detail program under the authority and supervision of the *Burlington County Detention Center*.

1. I understand that I have been legally committed into the custody of the Jail Administrator of Burlington County by order of a court of law and that it is the duty of the Jail Administrator or his designee to enforce that order.
2. I understand that all Rules and Regulations for inmates apply to weekenders as well. No weekender shall violate the disciplinary code of the Burlington County Detention Center. These Rules and Regulations are available upon request.
3. I understand it is my responsibility to process for my weekend sentence between Monday morning at 6:00 am and Thursday night at 11:30 pm. I also understand that I DO NOT receive credit for this time.
4. I understand the weekend hours established by the courts is from 8:00 am to 4:00 pm, both Saturday and Sunday. Roll call begins promptly at 8:00 am at which time I must be present to sign the weekend roster.
5. I understand that any absence, lateness or violations of these rules will be reported to the sentencing court for any reconsideration of my sentence. Any paperwork (Dr's note, obituaries, etc.) goes to the court.
6. I understand that the legal restraints against criminal acts while in custody are the same as those outside. In addition, I understand that the crime of escape (leaving or walking away from the program), and/or aiding and abetting an escape may be subject to confinement to a term in State Prison.
7. I understand that contraband is defined as any unauthorized item found on one's person or in the possession of one person and that institutional and/or criminal charges may be filed against me if such items are found and proven to have been on my person or in my possession. ***This includes but is not limited to: cell phones, cigarettes, lighters, matches, etc. and WILL NOT be returned.***
8. I understand that all weekenders are expected to participate in outside details and that I WILL come prepared (clothing, shoes, etc.) at all times.
9. I understand that the Correction Officers assigned to the weekend details are the CHARGE OFFICERS responsible for my supervision and that all weekend duties to be performed by me while at a job site will be assigned by these officers. In accordance with the orders of any weekend sentence, I will accept and perform all duties assigned to me by the CHARGE OFFICERS of the weekend detail. If I am unable to perform these duties I will provide documentation from a physician both to the detention center and the court.
10. I understand that it is my duty and responsibility to participate in the orderly operations of the weekend detail and that no weekend inmate shall attempt to disturb or disrupt these operations.

MY SIGNATURE BELOW CERTIFIES THAT I HAVE READ AND UNDERSTAND THE RULES AND REGULATIONS FOR ALL INMATES SENTENCED TO PARTICIPATE IN THE WEEKEND DETAIL PROGRAM AND THAT I ALSO ACKNOWLEDGE RECEIPT OF A COPY OF THESE RULES AND REGULATIONS.
